What is HIPAA Version 5010?

The CMS requirement to adopt (EDI) transaction standards originated from the 1996 Health Insurance Portability and Accountability Act (HIPAA).

The Transactions and Code Sets final rule published on Aug. 17, 2000, adopted standards for the statutorily identified Electronic Data (EDI) transactions.

On January 16, 2009, HHS published a final rule that replaces the current Version 4010/4010A.

What is “5010”?

- “5010” refers to HIPAA Version 5010 Transaction And Code Set Standards, regulated by CMS.
- “5010” is used when talking about electronic transmission of data or Electronic Data Interchange (EDI).
- Medicaid currently accepts and sends data via EDI using Version 4010
- Over 80% of Medicaid data is submitted via EDI from our Trading Partners, clearinghouses, and some providers.

What is the timeframe?

All Medicare and Medicaid programs are required by federal law to comply with the new version by January 1, 2012.


- MITS will have the ability to accept both 4010 and 5010 files by January 1, 2012
- MITS will return files in the same format as received from TPs
- 4010 will be terminated no later than 180 days past January 1, 2012

What Transactions are specified in 5010?

- 270/271 – Health Care Eligibility Benefit inquiry & response
- 276/277 – Health Care Claim Status request & response
- 278 – Health Care Service Notification & Acknowledgement
- 820 – Payroll Deducted and other Group Premium payment
- 834 – Benefit Enrollment and Maintenance
- 835 – Health Care Claim Payment/Advice
- 837 – Health Care Claim; COB & Subrogation claims & encounters
- National Council for Prescription Drug Programs (NCPDP)–
Pharmacy Encounters

Why Upgrade to HIPAA Version 5010?

1. Provides more consistency across all transactions
2. Increases the field size for diagnosis codes or ICD (International Classification of Diagnosis) codes
3. Increases the number of diagnosis codes allowed on a claim
4. Adds edits for common mistakes to the front end, rather than doing edits in the adjudication system
5. Provides common edit definitions
6. Assigns claim numbers closer to the time of receipt
7. Improves claims receipt and control
8. **Required by CMS for all “covered entities”**

Why upgrade to HIPAA Version 5010?

- Aside from CMS requirement, Version 5010 is needed to accommodate the forthcoming and mandatory implementation of ICD-10.
- International Classification of Diagnosis (ICD) codes were established by the World Health Organization as a way to collect and classify detailed descriptions of known diseases and injuries; by tracking mortality statistics.

Why upgrade to ICD-10?

- Every disease (or group of related diseases) is described with its diagnosis; given a unique code, up to 7 digits long.
- ICD-10 will impact rules, coding, data reporting for diagnosis codes, procedure codes, etc.
- From about 17,000 codes to 155,000 codes*

ICD-10 compliance date:
October 1, 2013.
