# Presentation Schedule for PDL

## **Guidelines for Presentations:**

1. Time limit of **7 minutes** per product, inclusive of any set-up/take-down time, will be strictly enforced.
2. Manufacturers may use their allotted time as desired, within the following limits:
  - a. Only the drug scheduled at that time can be presented
  - b. Anyone can speak for the manufacturer
  - c. Multiple presenters are allowed during each time frame, but all presenters combined should not exceed the scheduled time
3. Manufacturers not present or prepared to present at their scheduled time will forfeit their time frame to present.
4. A projector will be available for use – presenters must supply their own laptop computer.
